APEC Architect Monitoring Committee Republic of the Philippines

As was accepted at the Second Council Meeting held in Mexico City on the 23 and 24 of May of 2006, Mexico would act as Secretariat to the APEC Architect Project from the 1st of January of 2007 until the 31st of December of 2008. On the Third Central Council Meeting held in Vancouver, Canada on the 7 and 8 of August of this year, it was approved that the Republic of the Philippines would act as Secretariat from the 1st of January of 2009 on to the 31st of December of 2010.
